

ETHERBTC TERMS OF USE

By purchasing EtherBTC tokens (ETHB), you agree to the following terms and conditions:

USE CASE

EtherBTC (ETHB) is a cryptocurrency in the family of bitcoin, Ethereum and Litecoin, built on the Ethereum blockchain (ERC20 token) and limited in supply to 21,000,000 units. It can be stored in ERC20 compatible wallets, including MyEtherWallet, Mist, imToken, Parity, Metamask, Coinomi, and Ledger. It may be listed and sold on EtherDelta.com or ForkDelta.com.

PURCHASES

EtherBTC tokens may be purchased on the EtherDelta.com or ForkDelta.com decentralized exchanges using Ethereum, or may be purchased from <https://etherbtc.io> using multiple cryptocurrencies, including bitcoin, Litecoin, Ethereum, Dash, Monero, Zcash, and many more. Prices on exchanges are what individuals who purchased EtherBTC are willing to sell for, and may be less than prices offered directly thru the EtherBTC.io website. Prices offered on the EtherBTC.io website represents the official price for the EtherBTC token, and is not subject to adjustment based on what others are willing to sell ETHB for on an exchange.

DELIVERY

If you purchase directly, please allow up to 48 hours for your ETHB to be delivered. We will create a brand new MyEtherWallet, transfer your ETHB into that wallet, and email you the private key. It is recommended that you transfer your ETHB to another wallet after receipt.

WARRANTY

No warranty is expressed or implied with regard to ETHB, including fitness of use or future value.

TAXES

You are responsible for any taxes associated with the purchase of ETHB.

LEGAL

You are responsible for compliance with the laws of your jurisdiction regarding the purchase and ownership of cryptocurrencies.

INDEMNITY

To the fullest extent possible you agree to indemnify and hold harmless EtherBTC.io, it's owners, officers, employees, independent contractors, internet service providers and web hosting company, from any and all liability with regard to EtherBTC.

USE OF FUNDS
